We participated in the project titled M.A.N.O (Managers of Non Profit Organisations), which was a Leonardo Da Vinci project organised by the Italian GIOSEF Association. Within the framework of the programme, Eurotender Association hosted four young volunteers from Italy. The volunteers participated in the ongoing projects of the Association and they also generated new, mini-projects during their stay.



Eurotender Association is a member of the Hungarian Network of Anna Lindh Euro-Mediterranean Foundation. With the financial support of the Foundation, we conducted a project titled Restore Trust, Rebuild Bridges Between Roma and Hungarian Pupils in 2009. As a result of the success of our project, the Foundation invited our organisation to the Restore Trust Forum and Bestowing Ceremony of the Euro-Med Award on 21 September 2009, in Stockholm.

EUROTENDER ASSOCIATION

Eurotender Association was founded in 2005, with the aim of contributing to the success of the structural policy of the European Union in the South Great Plains region of Hungary. As a public benefit organisation, it wishes to foster social and economic cohesion.

Our operations include the support of disadvantaged people in the region, primarily improving the conditions of ethnicities, youth, elderly people, women and disabled people; examining the current state of the labour market and workplace health protection, and achiave sustainable development in harmony with the EU policies.

Our organisation is committed to regional development and territorial equality, and our main instrument for achieving these goals is the European Union's cohesive policy. We believe that the role of the civil sector is decisive in forming regional identity.

Through our main activities—training/education, production of training materials—we would like to support the intentions and measures aiming to foster the integration of disadvantaged groups into the labour market.

We also support activities, which enable workers to conduct their work in a better physical, spiritual and mental health. In cooperation with the association for large families of Szeged, the members of our organisation helped organising summer camps for children coming from large families. Our activists also acted as camp counsellors. These camps were financed by successful grant applications submitted to the Hungarian government (Ministry of Youth and Family Affairs).



We are committed to regional development and we realised that the primary instrument for this is the strengthening of civil society, civil organisations. The EU accession of Romania opened great opportunities for cross-border cooperation. Serbia is a potential candidate country for EU accession, so the civil society organisations of these three countries could all benefit from experience exchange. This is why we participated in the organisation of Youth in Civil Europe Conference (organised with the financial support of the EACEA).

Our Association also tries to foster the integrated education of Roma children in Hungary.

Therefore, we participated in a project titled Student Mentoring Programe in support of the Szeged desegregation measures since its beginning in 2007, which was funded by the Roma Education Fund.



In March 2007, the local government of Szeged and the Szeged Roma Minority Government initiated the close-down of a segregating primary school.

As a result, pupils from the school were transferred to 11 o ther institutions (2-3 pupils per class).

Within the Student Mentoring Program, 35 pre-service techers (student mentors) help the integration of pupils into their new classes both socially and academically under the
